Definitions of terms used in BioRAFT

- **Lab Profile:** Lab profile shows summary of basic information you enter during initial lab set-up. Provides tabs to review/edit your group information such as lab members, chemical inventory, equipment, etc.
 - **Lab/Laboratory:** Refers to a group working under a Principal Investigator (PI) or other faculty member. BioRAFT uses the last name of the PI to indicate the name of a lab group. *Example: Martin Lab, Gonzales Lab, etc.* “Lab” will also be used to identify non-lab groups – such as Transportation Services, TEEX, etc. – that use ChemTracker for chemical inventory management.
 - **Location:** This is the building name and number.
 - **Space:** This is the room number.
 - **Group Compliance Liaison (GCL):** GCL is a person designated by the PI as a liaison. GCL is included on all correspondences to PI and can act/respond to compliance requirements on behalf of the PI.
 - **ChemTracker:** Chemical inventory management module to be used to maintain chemical inventory records and Tier II reporting. [Click here](#) to access the TrainTraq login page for Course#2113979: Guide for Using ChemTracker-EHS.
